

A Social Accounting Matrix (SAM) is a database that shows flows of payments in an economy between households, producers, the government, and the rest of the world. SAMs are valuable inputs into economic research, primarily used to describe the structure of an economy, and as inputs to the databases of Computable General Equilibrium (CGE) models.
